# WARREN BOARD OF SELECTMEN REGULAR MEETING Wednesday, November 21, 2018

#### CALL TO ORDER:

Chairman Sackett called the meeting to order at 5:00 PM.

Select Board Members Present: Charles Sackett, Charles Chandler, and Lesa Romano.

**Staff/Officials Present:** Town Administrator – Austin Albro, Treasurer - Sheila Foote, Fire Chief - Art Heath, and Transfer Station/Buildings & Grounds Manager - George Russell. Chief of Police – John Semertgakis and Road Agent – Bobby Cass were here earlier, but were called out or needed to leave.

Public Present: Kellie Pinon

C. Sackett led those present in the pledge of allegiance to the flag.

**SELECT BOARD MANIFEST:** C. Chandler stated he had reviewed the manifest and had a few questions that were answered. *C. Chandler moved approval of the manifest as presented. L. Romano seconded the motion. Vote:* Sackett-yes, *C. Chandler-yes*, *and Romano-yes. The motion passed 3-0-0.* 

**APPROVAL OF MINUTES:** C. Chandler moved approval of the 11-7-2018 minutes. L. Romano seconded the motion. Vote: Sackett-yes, Chandler and Romano-yes. The motion passed 3-0 0.

## PUBLIC COMMENT:

- a. Arthur Heath announced the couple who bought the old Morse Building have donated a number of Christmas wreaths to the Town and he wanted to know where to hang them. Suggestions included the Town Hall, the Town Offices, the Library, and the Fire House. C. Sackett said thank you to the donors of the wreaths.
- b. George Russell said he and Austin Albro had met with John Dunster from Revision Energy to learn more about the potential for solar energy in Warren. He presented a proposal based on the Town's estimated energy use. C. Chandler said he was pretty impressed with Revision Energy's history of working with towns, colleges, and businesses, but would have to go to the voters. More research needs to be done for a warrant article. It was suggested that the Town Administrator follow up with other towns that have finished comparable solar projects, such as the Town of Madison. C. Sackett said to check the company's references and expressed concerns about the longevity and efficiency of solar projects. Administrator Albro stated that Mr. Dunster is willing to present to the Board. C. Chandler thought that was a good idea. The Board understands there is urgency to take advantage of incentives that will keep the cost of the project down. The Board will consider preparing a non-binding warrant article, if the result of our meeting moves us in that direction. The Board agreed there was no need for a motion at this time.

## ROAD AGENT REPORT:

Road Agent Bobby Cass reported to C. Chandler prior to the meeting and but was not present due to inclement weather.

# TREASURER'S REPORT:

Treasurer, Sheila Foote reported the Town of Warren Operating Account balance is \$305,552.90 after tonight's approved manifest of \$24,951. 31. The reconciliation reports were provided for the Select Board's review.

The Tax Collections Account balance is **\$59,190.11**. The reconciliation reports were provided for the Select Board's review.

C. Chandler moved to accept and approve the Treasurer's report. Seconded by L. Romano. Voting in favor of the motion were Sackett-yes, Chandler-yes, and Romano-yes. The motion passed 3-0-0.

# TAX COLLECTOR'S REPORT:

The Tax Collector provided a report to the Board for review.

- c. LUCT Assesor, Richard Dorset prepared a land use change tax for Warren Sand and Gravel, at the request of NH Department of Revenue.
- d. H&H Studies: Ore Hill & Week's Crossing An updated proposal will be coming from HEB Engineers in time for review prior to the next meeting.

## **OLD BUSINESS:**

- a. Beech Hill Parking C. Sackett and C. Chandler went up to Beech Hill Road to look at the area with the no parking signs. They agreed the road definitely has a safety concern with a lack of vision of on-coming traffic in both directions. The Board requested that the no parking signs be spaced apart, approximately 200 feet but visible from one another. Violators will be ticketed and fined if there are continuing violations and the vehicles will be towed at the owner's expense. No additional signs will be posted without the Select Board's permission.
- b. Bake River Berm Removal Project The berms will be removed begin as soon the necessary equipment arrives. Administrator Albro expects the equipment to arrive by the end of the week.
- c. Current Use Update Richard Dorsett completed a land use change tax indentified by NH DRA and continues to review others. Administrator Albro is working with the assessor to establish new, updated current use files.
