# WARREN BOARD OF SELECTMEN REGULAR MEETING Wednesday, June 19, 2019

#### CALL TO ORDER:

Chairman Sackett called the meeting to order at 5:00 PM.

Select Board Members Present: Charles Sackett and Charles Chandler.

**Staff/Officials Present:** Town Administrator – Austin Albro, Fire Chief - Art Heath, Chief of Police – John Semertgakis, and Transfer Station/Buildings & Grounds Manager - George Russell. Deputy Fire Chief/WVSB - Don Bagley Sr, Treasurer - Sheila Foote and Road Agent - Bobby Cass were not at the meeting, but provided a written report.

**SELECT BOARD MANIFEST:** C. Chandler moved approval of the manifest. C. Sackett seconded the motion. Vote: Sackett-yes and Chandler -yes. The motion passed 2-0.

**APPROVAL OF MINUTES:** There was brief discussion regarding the school payment for Fiscal Year 2020. C. Chandler stated that the Board would accept the treasurer's recommendation and continue to pay the same amount. C. Chandler moved to approve the 6-5-2019 minutes as presented. C. # TREASURER'S REPORT:

Treasurer, Sheila Foote was not at the meeting, but provided a written report. She stated the Town of Warren Operating Account balance is **\$249,780.70** before tonight's approved manifest total of \$30,251.52. The May reconciliation report was provided to the Board for their review.

The Tax Collections Account balance is \$155,095.40. The May reconciliation report was provided to the Board for their review.

The Paving Fund Account balance is \$110,000.00.

The Treasurer will be away from June 19<sup>th</sup> through July 2<sup>nd</sup>, 2019. The Deputy Treasurer will cover the office at her convenience, during her absence.

# **ROAD AGENT:**

Road Agent Bobby Cass provided a written report stating he has been working on Batchelder Brook Road. He will be moving to Beech Hill Road next. He has been pricing tires for the trucks for next winter.

When Beech Hill Road is all set for paving, he will go to the top of the road and start cleaning ditches.

#### FIRE DEPARTMENT:

Fire Chief, Art Heath reported they had responded to a vehicle fire at the Ravine Lodge. Woodstock Fire Department also responded. The Chief reported on recent training activities and stated all of the fire fighters are now qualified to drive the Rescue.

# TRANSFER STATION/BUILDINGS & GROUNDS REPORT:

Manager, George Russell:

<u>Transfer Station:</u> G. Russell reported tires and cardboard have been sent out for disposal. He said that we are closer to being able to accept plastics and explained that residents do not remove the labels, but please rinse them out. There will be additional help at the Transfer Station once plastic recycling has started to better assist residents.

<u>Buildings & Grounds:</u> G. Russell reported he is in full scheduling for mowing. He asked the Selectboard if he could get a team of 3 to 5 people together to help cover the Willing Workers Hall roof in Glencliff, as it is leaking. The Selectboard saw no issue.

# **TOWN ADMINISTRATOR:**

- a. Austin Albro reported the assessor was in today and will be back in two weeks to complete LUCT outstanding items.
- b. HSEM has granted extensions for some of the mitigation projects that will allow the town through the 2021 construction season to complete.
