The Highway Block Grant of \$11,678.50 has been received.

TAX COLLECTOR'S REPORT:

The Tax Collector provided a report to the Board for review.

FIRE DEPARTMENT:

Fire Chief, Art Heath reported the department provided mutual aid to Rumney at Stinson Lake. On Sunday, they had a mutual aid call to Wentworth that was cancelled half way there. They had a second call from Wentworth with the same results.

There was a short discussion about parking at Breezy Point. With the hot weather the increase of people at the Breezy Point swimming hole, parking has been tight.

CHIEF OF POLICE REPORT:
